

**Flute Asylum Release and Waiver of Liability  
for Shipping your Instrument  
(TO TOM'S HOME SHOP during Covid-19 Pandemic)**

**Insuring shipment of your instrument from our repair shop to you:** you may either provide your own insurance coverage or instruct Flute Asylum to purchase shipping/freight insurance on your behalf up to and including the value of the instrument as declared by you below. You understand that Flute Asylum will not purchase shipping/freight insurance on your behalf unless you request it to do so in writing by filling out the form below. If you elect for Flute Asylum to purchase coverage on your behalf, you agree to pay the cost of such coverage. You understand that the cost of such coverage is determined by the carrier.

**Your responsibility:** if you elect to provide your own insurance coverage, it is your responsibility to confirm whether your insurance coverage includes shipment of your instrument from our repair shop to you. We encourage you to check with your insurance carrier to ascertain the scope of your coverage before shipment.

**Release and waiver of liability:** Regardless of whether shipping/freight insurance has been purchased by you or by Flute Asylum on your behalf, you assume all liability associated with shipment of this item. By signing this Release and Waiver, you irrevocably release and discharge Tom Peterson, Flute Asylum from any and all damages to the instrument and all other causes of action, claims, costs, and any other liability that arise from the shipment of your instrument. You agree to assume all risks with regard to such shipment and waive any liability as to Tom Peterson, Flute Asylum.

**Claims:** regardless of whether you provide your own insurance coverage or instruct Flute Asylum to purchase shipping/freight insurance on your behalf, you agree that you are responsible for handling any and all claims that arise or are submitted as a result of shipping your instrument, except as required by the shipping carrier. You agree to submit any such claims directly to the insurer. Flute Asylum has no responsibility for submitting or handling claims on your behalf, except to supply information as required by shipping carrier.
